YA Dr Johan is currently a high court judge of the Kuala Lumpur high court. He was previously in active legal practice and was the managing partner of J. Lee & Associates, a medium-size awards-winning legal firm in Malaysia.

He graduated with LLB (Hons) degree from International Islamic University Malaysia. He also holds a Master of Comparative Laws degree, a post-graduate Diploma in Shariah and Legal Practice both of which from International Islamic University Malaysia, a MA in Economics for Competition Law from King's Collage London and a Ph.D in Business and Commercial Law from Monash University Australia. He was an advocate and solicitor of the High Court of Malaya, High Court of Sabah & Sarawak, the Shariah Court and the Supreme Court of Brunei.

YA Dr Johan has immense interest in competition law and policy. His master dissertation analysing the economic aspects of vertical restraints had ranked him among the top of his class which consisted of competition judges, regulators and lawyers worldwide and earned him a Master of Art (with Merit) in Economics for Competition Law from King's Collage London. His doctoral research conducted at the Law Faculty of Monash University, Australia had, among others, critically examined the economic and legal aspects of dominants' strategic conduct in various jurisdictions and proposed numerous legal reforms especially for small open economy like Malaysia.

Up till his elevation, he lectured part-time in a few local law schools (namely IIUM for the LLM and Sultan Zainal Abidin University - UniSZA and University Malaya for the LLB programmes) and in the liBF of IIUM for the MSc. in Islamic Banking programme since 2001. In 2006, he was a visiting scholar to the Asian Law Centre of the University of Washington. Besides, he was a member of the Board of Studies of the Institute of Islamic Banking and Finance, International Islamic University Malaysia for the 2010-2012 tenure. He was also a member of the Board of Studies of the Faculty of Law of University Malaya for the 2015-2017 tenure.

He has authored few text books and reference books and written few articles globally. YA Dr Johan was elevated and appointed as a judicial commissioner effective 1st April, 2021. He has recently been confirmed as a high court judge of the High Court of Malaya in June, 2023. He is currently entrusted to hear and decide cases in the Civil division of the High Court of Kuala Lumpur. He is currently an adjunct professor of the UUM School of Law of UUM College of Law, Government & International Studies of the Northern University Malaysia. He is also a member of the Board of Studies of the Faculty of Law of University Malaya for the 2021-2023 tenure.

YA Dr is currently updating his doctoral thesis and intend to publish a reference book on competition law to explain and elucidate competition law and policy in Malaysia for lawyers, students and general public.
