The President's Report For the year 2023

Delivered at the Annual Delegates Conference 2023

Introduction

- 1. I am pleased to present the 2nd Report of the President. The 1st Report was delivered to all members by email on 22nd February 2023.
- 2. At this juncture, it would be opportune to remind ourselves that this is the Annual Delegates Conference where the importance of this conference is entrenched in our **Constitution under Clause 25 (a)** where it reads:-

"The Delegates Conference shall constitute the supreme authority of the Association"

3. The Association through the Central Committee and the Branch Committee undertakes a wide range of activities in accordance to the Objects and Powers of the Association as set out under Clause 3 of the Constitution. The members would note that some activities have propelled the Association into the sphere of international recognition and cooperation with international bars on issue of corresponding relevance to our practice here in Sarawak.

Central Committee Meeting

- 5. The Association also had a number of other meetings which were called to attend to urgent matters which include the discussions towards the petitions for admissions, ad hoc petitions etc.
- 6. The Association also utilizes the Central Committee Chat Group as a means to discuss and decide on certain matters. Thereafter, the issues decided upon shall be ratified in the Central Committee Meeting.

Administration of the Association

7. The members would note that at present, the Association is operating the Bar Room in the Miri Court Complex where the President is predominantly

practicing. We are grateful to the Association's Miri Branch in welcoming the Central Committee's use of its Bar Room, and we also acknowledge the assistance and the support rendered to the Central Committee over the years.

- 8. The Association operates through the Secretariat. The Secretariat comprises of the Honorary Secretary Mr David Teo, the Assistant Secretary Ms. Christine Lim and Ms Ina from the Bar Room these individuals are the bedrock to the Association, where they manage the day-to-day functions of the Association, a role which includes a wide range of responsibilities from reviewing of the papers submitted for your Practicing Certificates to organizing the meetings/engagement sessions and following up with the relevant authorities/court on pending matter.
- 9. I cannot stress how important the role of the Secretariat is to the Association, and I would like acknowledge their hard work and unwavering commitment to the Association.

Opening of the Legal Year, 13th January 2023 - Miri Sarawak

- 17. OLY 2023 was announced to be held in Miri during the OLY 2022 in Kota Kinabalu Sabah, although initially the then Chief Judge of the High Court of Sabah & Sarawak Tan Sri Abang Iskandar intended to announce the OLY 2023 to be in Kuching. The Association's Miri Branch took up the task of coorganizing the program with the Judiciary on behalf of the Advocates Association of Sarawak.
- 18. The Association's Miri Branch had also co-organized the National Symposium on Islamic Banking and Finance 2023 to be held on 14th to 15th January 2023 with the Association of Islamic Banking Institutions Malaysia (AIBIM) where there were 250 participants.
- 19. I am pleased to inform that the OLY 2023 was a resounding success where there were 650 people attending the Gala Dinner organised in conjunction with the OLY 2023. I would like to acknowledge the job well done by the Association's Miri Branch lead by its chairman Mr. Lee Jin Wen and his committee. Thank you for keeping up the standard of such programs organized in Sarawak.

Tripartite Bar Games, 12th to 14th October 2023 at Bintulu

- 20. The Advocates Association of Sarawak Bintulu Branch hosted the 2023 edition of the Tripartite Bar Games from 12th to 14th October 2023 in Bintulu. A total of approximately 200 advocates from West Malaysia, Sabah and Sarawak attended and participated in the TBG 2023.
- 21. The highlight of the TBG was the Gold Medal achieved by the Football Team lead by Mr. Robert Lau as the association last won some 20 years ago. It is also noteworthy that the Association was placed at a respectable 2nd place behind the Bar Council.
- 22. The Association's Bintulu Branch also deserves a GOLD MEDAL for the stellar performance in taking up the challenge to organise the TBG, and then excelling at it. The feedback received from our learned friends from West Malaysia and Sabah was that of surprise and admiration that our smallest branch was able to pull off the TBG and that too at such a high standard of hospitality. Congratulations to the Bintulu Branch Chairman Mr. Ma Seong Yuin and your committee members for a job well done.

AAS Young Lawyer & Pupil Workshop 1st to 3rd December 2023

- 23. The workshop was held in Kuching, Sarawak commencing on the 1st to 3rd December 2023 to facilitate the young advocates pledges given during the admission to the High Court of Sabah & Sarawak, and for incoming advocates to comply with Rule 9 of the Pupillage and Admission Rules and the Directive of the Chief Judge of the High Court of Sabah and Sarawak dated 10th October 2019 for pupils to attend an Advocates Training Course. Further, the workshop will also facilitate the young and incoming advocates to be able to take up the 20 YGBK cases as per their pledges to the Court.
- 24. We are pleased to note that the speakers for the Workshop were:

- 25. It is heartwarming to note that such esteemed speakers were willing to answer the call of the Association to share their knowledge and experience with our advocates. We record a sincere note of thanks to all speakers and we look forward to the next chapter of the Workshop.
- 26. There were 115 participants at the workshop and the Association has received very favourable feedback from the participants.

ADR in Sarawak

- 27. On this front, we take cognisance that there is an inevitable move towards ADR, where such move includes proposal to amend the Rules of Court 2012 to include a mandatory provision for all cases to be sent for mediation before such cases proceed to hearing/trial. BHEUU is also reviewing existing laws to include the Singapore Convention on International Mediation to be implemented in Malaysia. Having said that, have no doubt that the Association is on top of this and have started engaging with ADR providers in Malaysia to set up course for our members in Sarawak. At present, we have received numerous proposals from AIDAR, AIAC, MIMC and we are also considering to set up such ADR courses with University Malaya. The association has been having a number of engagement sessions with ADR providers in Malaysia and will update the members in due course on the training to be offered to all members interested.
- 28. The Association has also been invited to participate in the setting up of an ADR centre in Sarawak. Initial discussions were held by the Association with BICAM and AIAC where both providers have had audiences with the State Government. In fact, the State Government has also identified a heritage building as the centre for ADR in Sarawak, where we have been made to understand that renovation works have commenced to convert the building into a suitable ADR Centre. The Association was then informed that the State Government wishes to proceed with the AIAC-Sarawak choice and made such decision for a number of reasons. The Association has been invited by the State Government to participate in the move to set up AIAC-Sarawak where it is needless to say that the Association will play the role of ensuring that there are (among others) adequate protection towards the local ADR practitioners in the agreement between the State Government and AIAC.
- 29. This matter will be further discussed during the ADC and we shall inform the members accordingly in due course.

Increment of LONO Fees

30. At present, advocates in West Malaysia pay around RM1512.00 per year for their practising certificate (including the fees for mandatory courses). In

Sabah, advocates pay RM750.00 per year. However, in Sarawak, Advocates only pay RM 96 per year to the Central Committee to obtain our practicing certificate.

- 31. There is an obvious need for the LONO fees to be increased to the range of RM50 to RM100.00 RM150.00 as this would assist the Central Committee to raise the necessary funds to firstly operate the Bar Room and Secretariat in a more professional manner including potentially hiring a Manager of the Association to attend to administrative tasks. Secondly, to enable central to organise more courses for our young/new members at discounted rates or potentially free of charge. Thirdly, to facilitate participation of our members and committee members in programs/engagements. These are just a few pertinent reasons for increment of the LONO fees.
- 32. The amount paid by our members is far too low considering the strides the Association is making and the future programs planned. I hope the members would vote for this favourably during the ADC.
