On 20-1-23, YB Ramkarpal visited Kuching Court and announced that as a temporary measure, each court room in Kuching will be installed with one unit 4 horsepower air conditioning unit immediately after Chinese New Year.

MEETING WITH YB DATUK HJH SHARIFAH HASIDAH, YB DATO SRI WAN JUNAIDI, DATO SUDRA RAJOO AND SARAWAK STATE ATTORNEY-GENERAL DATO SRI TALAT MAHMOOD ON THE SETTING UP OF ASIAN INTERNATIONAL ARBITRATION CENTRE (AIAC) SARAWAK On 12th May 2023, Upon invitation by Deputy Minister in the Premier's Department (Law, MA63 and State-Federal Relations), Mr President and myself attended the meeting on behalf of Advocates Association of Sarawak with YB Datuk Hajah Sharifah Hasidah, YB Dato Sri Wan Junaidi, Sarawak State Attorney-General Dato Sri Talat Mahmood and AIAC team lead by Dato Sudra Rajoo on the setting up of Asian International Arbitration Centre (AIAC) Sarawak.

We were briefed by YB Datuk Hajah Sharifah Hasidah that the premier has given his green light for the AIAC Sarawak Chapter. AAS will play a role in the advisory committee which decides on the direction AIAC Sarawak takes. The state government has earmarked the textile museum building as the centre here and AIAC will extend a contract for the government's consideration. YB Datuk Hajah Sharifah Hasidah has requested AAS to consider allowing foreign arbitrators to take up arbitration in Sarawak and allow some give and take. We have informed her that we would seek member's input on this matter.
