2. <u>OPENING OF LEGAL YEAR ("OLY") 2023 AND NATIONAL SYMPOSIUM ON ISLAMIC BANKING AND</u> <u>FINANCE 2023</u>

Miri branch has been conferred the task of co-organizing with the Judiciary for the OLY 2023 (OLY 2023) on behalf of the Advocates Association of Sarawak on 13th January 2023. In conjunction to the OLY 2023, the Advocates Association of Sarawak (Miri Branch) is Co-Organizing with Association of Islamic Banking Institutions Malaysia (AIBIM) a back to back event which is the National Symposium on Islamic Banking and Finance 2023 to be held on 14th to 15th January 2023 also at Pullman Hotel Miri.

On the 27th May 2023, Miri branch had the opportunity to host a dinner with Chief Justice of Sabah & Sarawak, The Right Honourable Tan Sri Dato' Abdul Rahman bin Sebli, together with Miri High Court Judge, YA Dean Wayne Daly and other Judiciary Officers at Mercure Hotel Miri. The dinner was also attended by the President, Secretary and Immediate Past President of the Central Committee together with our committee members.

5. <u>PIASAU NATURE RESERVE</u>

On the 23.05.2023, the Association together with the Sarawak Court Working Group on Environment (SWGE) and Miri Court organized this program in PNR to raise awareness towards the conservation of Hornbills in the gazette nature reserve.
