This report covers the activities of the Kuching Branch from 26.11.2021 to 24.11.2022 and also activities and programs in which we had represented our Kuching member.

The Activities and events that took place during the period under review are set out under the various headings appearing below.

OPENING OF LEGAL YEAR

- OLY 2022 for Malaysian was held in Putra Jaya on 14th January 2022 in compliance with Covid 19 restrictions via Zoom. AAS Kuching Branch was represent by the Chairman via zoom
- OLY 2022 for Sabah and Sarawak was held in Kota Kinabalu Sabah on 20.1.2022. in light of Covid restrictions only the members of the Central committee were invited to attend. AAS Kuching Branch Chairman was represented by Dayangku Saadiah

CONTINUING LEGAL EDUCATION AND TRANING

- Advocacy Training was held via Zoom on 7th, 8th and 145th January 2022. It was organised by Mr Desmond and there were 24 participants.
 We had trainers from Sabah Law Society and Malaysian Bar assisting our Sarawak trainers in conducting the training.
- 2. Advocacy Training was held via Zoom on 10th 11th and 12th June 2022. It was organised by Mr Desmond and there were 8 Participants for advocacy training and 6 senior lawyers trained to be trainers for future training. We had trainers from Sabah Law Society and Malaysian Bar assisting our Sarawak trainers in conducting the trainings.

- 5. YBGK training was conducted on 16.7.2022 at UPC. Though the trailing was organised by Central committee, Puan Dayangku Saadiah Kuching branch had assisted in its organisation. The trainers were Mr Abdul Rahman Hazmi and Mr Simon Siah.
- There was Informal Get Together held on 25th March 2022 at Perdu Café. The Topic was : An Introduction to Advocates Association of Sarawak by Mr Sarbjit Khaira
- There was an Informal Get Together held 13th May 2022 at Noir Bar. The Topic was : The Industrial Relations (Amended) Act 2022 by Mr Arthur Lee Cheng Chuan and Hii Yew Heng

- There was an informal get together held on 29th July 2022 at Noir Bar. The topic was -Civil Procedure – A Basic Overview by Mr Desmond Sahathevan and Mr Adrian Chew
- 9. There was also a talk jointly organised by AAS Kuching Branch and Pertubuhan Insuran Sarawak on 17th june 2022. The Topic was "The Common Misconception on Validity of Motor Insurance Policy "the Speakers were Sarbjit Singh Khaira and Liew Tang Chieh. It was attended by about 70 participants

DIALOGUES / MEETINGS

- There was a meeting with CJSS on 30th March 2022 at High Court, Kuching. Most of AAS Committee members attended the meeting. Various issues were discussed
- There was a reference Proceedings held for 3 departed Sarawakian Judges on 14th June
 22 at High Court Kuching. Though it was organised by the central committee but Kuching Branch assisted in many aspects.
- 3. There was a Meeting with reprentative of Singapore Law, Mr Anil Changoroth who is the vice chair of their International Relations Committee on 8th, July 2022. All members of AAS Committee Members branch attended. We discussed about development of law in these two countries, how Singapore law society could work with AAS to organise trainings and Seminars for professional development.
- 4. Kuching Branch also participated in Judiciary's program called ""Jelajah Kehakiman". The event was held 24th & 25th September 2022 at Plaza Merdeka. Kuching where we had a booth to disseminate information about YBGK and the role of AAS in the legal profession. It was overseen by Mr Desmond and Alan Bong amongst others.
- Kuching Branch through Puan Dayangku Saadiah also represented AAS for Majlis Perasmian Bangunan Suruhanjaya Syrikat Malaysia Sarawak on 12th November 2022.
